

## 2024 Impact Report



According to the 2022 ALICE Report, sponsored by the United Way of Illinois, there are 11,101 households in Logan County, Illinois. Of those households, 39% of them are struggling to make ends meet, even while working. The United Way works to support organizations and programs that help fill the gaps that exist between income and expenses in local households. The United Way wants everyone in our community to thrive by bringing people and resources together to provide for needs and work for a better community.

## Dolly Parton's Imagination Library in Logan County

In 2020, the United Way of Logan County partnered with the Hartsburg-Emden School District to bring Dolly Parton's Imagination Library to the children of Logan County. Thanks to generous funding from foundations, businesses and individuals, the program was made available to all preschoolers in the county in 2023. During the year 2024 an average of 724 children per month received free books sent to their homes. 8,682 books were sent out to be enjoyed by the children during the year, and to encourage reading together at home to increase literacy readiness for school and to grow a love of books and reading. 20,876 books have been sent to homes since the program began in Logan County in 2020. The State of Illinois is now funding 50% of the cost of this program, and working to expand the program throughout the state, because of its impact on literacy and academic success. ## 2-1-1 in Logan County



United Way sponsored 2-1-1 is an easy to remember telephone number that connects people with important community services. When people in Logan County need help with housing, utilities, food, or mental health, 211 is just a call or click away with support in multiple languages. In 2024, **152 calls** came into the 2-1-1 line from Logan County residents, **and 182 needs** were identified with **207 referrals** provided to connect residents to the help needed. The top four needs identified in our county last year were (1) Housing (38%), (2) Utilities (18%), (3) Income and Employment (12%) and

Transportation (8%). The State of Illinois has identified the value of 2-1-1, and made provision in its budget over the last two years to help support the expansion of 2-1-1 throughout the state, making help available for everyone when needed. The state is on track to have 100% coverage by the end of 2025.
